# Membership & Program Policies– Page 1

## **Resident Rates**

Bennett Park and Recreation District rates apply to those who reside within the Adams County portion of the Town of Bennett. Proof of residency includes one of the following: water bill, lease agreement, or utility bill. A driver's license is not accepted as proof of residency.

## **Your Membership Card**

Your membership card is your access to Bennett Park and Recreation District (BPRD). Membership cards must be presented during each visit. When purchasing a Membership, you must present proof of residency.

Lost or stolen membership cards must be replaced. The fee is \$5.00. Members are granted one courtesy entrance without a pass. No other exceptions will be made.

## **Expected Behavior**

Bennett Park and Recreation District is an inclusive, family-friendly organization. We expect all our members and guests to model good sportsmanship, kindness, honesty, respect, and responsibility—in their conduct and language. BPRD has the right to terminate a membership at our discretion if actions or behaviors are not deemed in the best interests of the organization; no refund or credit will be issued.

- No running or horseplay in the hallways.
- Profanity or vulgar language is not allowed.
- Food or drink will only be allowed in the front lobby and hallway or approved areas. All other areas are for exercise and recreational activity. Drinks in plastic bottles with re-sealable tops and water bottles are an exception.
- No fighting. There is a zero tolerance for violence, harassment, or intimidation of any sort.
- All clothing attire must be worn appropriately. Shirts and shoes must be worn at all times. Non-marking athletic shoes are allowed. Shorts and pants must not be sagging.
- Alcoholic beverages, smoking, illegal drugs, firearms and tobacco products are not allowed in the recreation center.
- Bicycles, roller blades, and skateboards are not permitted in the building.
- No soliciting for personal gain: or approaching guests for the purpose of obtaining signatures for petitions within the building.
- No harassment of any kind, to any other guests or staff.
- Theft should be reported immediately to staff at the front desk who will file an incident report with local law officials.
- Vandalism: The recreation Center interprets vandalism as the willful or malicious destruction or defacement of property. The Recreation Center has zero tolerance to any damage caused by vandalism. The Director will determine disciplinary action taken due to vandalizing the center.

Violations of any of the above policies will result in either a verbal warning or outright ejection from the Bennett Recreation Center. Any negative behavior may result in loss of facility privileges and denied access to the facility. **Failure to comply with the policy after being notified by a staff member may result in the summoning of the local police and prosecution in accordance with the law.**

## Membership & Program Policies– Page 2

### **Bringing Guests**

With your annual classic or deluxe membership, you will receive guest passes. They must be used within the year of membership purchase, no exceptions.

### **Physical Readiness**

Before starting any exercise program, please check with your primary care physician. Talk with our fitness center staff to get recommendations on our cardiovascular machines, free weights, and circuit training machines.

At times, special events dictate that fitness room schedules be modified. Notices will be posted when this happens.

### **Definitions of Membership types:**

**Families:** A family membership consists of immediate family members defined as follows: Mom/Dad/Guardian and their children (or custody of grandchildren) 18 and below whom are their tax dependents. If the family has children that are 18+ and in college or the child is 18+ and ADA, then they may be added to the family membership. Any other combinations of family members are not permitted to be on the family membership.

*A family is considered 2 adults and their 3 tax dependents. Additional tax dependent family members may be added at a one-time rate of \$75 per dependent.*

*An additional senior living in household, or on property may be added to a family membership at ½ the amount of the senior membership rate.*

**Couples:** A couple consists of two people on the same membership. Acceptable combinations are: Two adults, an adult and guardian child, or any other combination that has two consenting adults that choose to be on the same membership.

**Senior:** A senior is a person who is 60 years or older.

**Adult:** An adult is a person who is 19 years - 59 years of age.

**Teen:** A teen is person 13 years -18 years of age.

*Teen members may not sign membership form or credit card form. The membership form and credit card form must be signed by guardian or Parent of Teen.*

**Youth:** A youth is any child 6 months - 12 years of age

*Youth member may not sign membership form or credit card form. The membership form and credit card form must be signed by guardian or Parent of Youth.*

### **Inclement Weather**

In cases of bad weather, the Bennett Park and Recreation District will be closed if the local schools are closed. If we are open and the highways closes due to inclement weather, we may close early to allow for safe travel for our patrons and employees.

### **Membership Benefits:**

Basic Memberships Basic use of the facility; weight room, basketball court, cardio equipment, lap swimming, and open swim (when available). This membership does not include continuous pool or fitness classes.

Classic Memberships receive 10% discount for leagues and youth programs (only if the child is included on the membership). Includes land classes, continuous pool use, daily utilization, open swim, and lap swim.

Deluxe memberships receive 15% discount for leagues and youth programs (only if the child is included on the membership). Includes land and aquatic classes, continuous pool use, daily utilization, open swim, and lap swim.

### **Discounts:**

~ Discounts apply to person owning the membership only.

~Child must be included in membership to receive any discount on youth programs/leagues.

~25% for classic and deluxe membership discounts is applied to all new memberships with valid ID for military, emergency personnel, and teachers. 10% discount for classic and deluxe renewals.

**League Discounts:** 10% for classic members, 15% for deluxe members. NO discount for basic members.

## Membership & Program Policies– Page 3

### **Weight Room/Cardio Area**

Individual's must be 14 years of age to use the equipment in the weight room. 11 years of age may use equipment if a parent/guardian is with them and watching at all times.

### **Weight Room/Cardio Area Rules**

1. Wear shirts and shoes at all times.
2. Share equipment in between sets.
3. Monopolizing equipment slows the workouts of others. Please, help maximize use.
4. Keep equipment in the weight rooms.
5. Help us prevent theft and maximize equipment use by keeping it where it can be seen and used.
6. Re-rack weights immediately when finished with them.
7. Help us keep the weight room safe and accessible to as many users as possible.
8. Store belongings in area provided.
9. Please wipe off equipment after use.
10. Children 10 and under are not allowed in the weight room under *any circumstances*.

The weight room is full of items that can be a danger to small children which is why we do not allow them in the weight room for any reason. Please make other arrangements for your children when you visit our facility.

Discovery Time Kids is available Monday through Friday from 6am-6:30pm for drop in childcare. BPRD members receive a discount on these fees. Please visit Discovery Time Kids for more information.

1. Don't drop or bang weights.
2. Avoid distracting others. Please respect others need to concentrate.
3. Be mindful of safety.
4. Do not step on the weight benches.

### **Pool Rules/Regulations**

Although swimming is a fun way to get exercise and enjoy the water, we also want you to be safe in and around the pool. A complete listing of pool rules is posted in the pool area, but here are a few that you need to be aware of before coming to the pool.

**All patrons must take a shower, getting wet from head to toe, before entering the water.**

Proper swimming attire must be worn at all times. (No street cloths, no basketball shorts)

**Only children 5 years of age or younger are permitted in the toddler pool.**

There is no lifeguard on duty during lap swim. Swim at your own risk.

The continuous pool is available by reservation only to classic & deluxe members.

**THERE ARE NO CHILDREN (under the age of 18) PERMITTED TO BE IN THE POOL AT ANY TIME UNLESS THERE IS SCHEDULED OPEN SWIM. Please see rules for open swim below:**

- Children 5 years and younger must have a chaperone (15 years or older).
- Children 6-10 years old must be accompanied by a chaperone 13 year or older.
- Children who are not potty-trained must wear swim diapers.

## **Cancelation and Refund Policies**

### **Membership Refund Policy**

Membership fees are non-refundable and may not transferred UNDER ANY CIRCUMSTANCES. Please check your statements regularly, if you notice a discrepancy in your bank statement, notify us promptly. Refunds are not issued for discrepancies over 60 days. We reserve the right to terminate a membership at any time, no refund will be issued. You also reserve the right to cancel your membership at any time but there will not be any refund or credit given for memberships paid in full. Cancelations of monthly paid memberships will incur a \$50 cancelation fee for early termination.

**Memberships can be put on hold up to 1 month for any reason, and up to 3 months for medical reasons. Any reason further is based on director's consent.**

*Should your annual monthly membership payment not be received per the BPRD agreement timeframe, you will be allotted 30 days to bring account current. If it is not brought current within the 30 days your membership may be subject to cancelation. You may not qualify for monthly payment options again should you choose to re-activate your membership.*

## Membership & Program Policies– Page 4

### **Program Cancellations**

The purpose of our credit policy is to allow Bennett Park and Recreation District (BPRD) to offer quality programs and proper class ratios while maintaining flexibility to our members.

BPRD reserves the right to cancel or combine classes because of insufficient enrollment or conditions beyond our control. If we cancel any class in which you are enrolled, you will be given a full refund or credit.

Program credits are applicable toward any BPRD program. Credits are not redeemable for cash. Credits are good for one year from the date of issue. No refunds or credits are given for gift certificates or memberships. In order to keep our class fees as low as possible, we will not be able to issue credits for missed classes or activities. Make-up classes are not available due to missed classes if not caused by recreation closures or instructor cancellations, this includes but is not limited to swimming lessons and aquatic classes.

### **Program Refund Policy**

A 100% program registration fee refund will be issued only if a request for the refund is made no less than three business days prior to the start date for the program. A 50% program registration fee will be issued only if a written request for a refund is received prior to the second scheduled meeting of the program. There will be no program registration fee refund given after the second scheduled meeting of the program except as defined under Medical Refund Request.

### **Medical Refund Request**

A pro-rated program registration fee refund will be issued based upon the amount of time/sessions remaining in the membership/program. The refund will only be granted upon written request when accompanied with medical documentation identifying a medical problem which prohibits the individual's continued participation.

### **Swim Lesson Refunds**

Refunds must be requested 48 hours prior to the close of registration. Refunds will not be given after registration has closed except when an illness or injury has occurred prior to the first day of class or when the class is canceled due to lack of participation. All other requests for refunds must be submitted, in writing, to the aquatics office prior to the first day of class. There will be a \$5 processing fee per child, per class, for all changes and/or individual-cancellations once registration has taken place.

### **Rental Facilities Refunds**

Cancellations must be submitted in writing, at least 7 business days prior to date of use in order to receive a full refund. Any requests from 4-6 days in advance may be considered for a 50 percent refund. Any request for refunds submitted less than 4 days in advance will not be accepted.

### **Birthday Party Refunds**

Cancellations must be submitted in writing, at least 7 business days prior to date of use in order to receive a full refund. Any requests from 4-6 days in advance may be considered for a 50 percent refund. Any request for refunds submitted less than 4 days in advance will not be accepted.
