Resident Rates

Bennett Park and Recreation District rates apply to those who reside within the Adams County portion of the Town of Bennett and Watkins. Proof of residency includes one of the following: water bill, lease agreement, or utility bill.

Membership Refund Policy

MEMBERSHIP FEES ARE NON-REFUNDABLE OR TRANSFERABLE TO ANOTHER

PERSON UNDER ANY CIRCUMSTANCES. Please check your statements regularly, if you notice a discrepancy in your bank statement, notify us promptly. Refunds are not issued for discrepancies over 60 days. We reserve the right to terminate a membership at any time, no refund will be issued. You also reserve the right to cancel your membership at any time but there will not be any refund or credit given for memberships paid in full. Cancelations of monthly paid memberships will incur a \$50 cancelation fee for early termination.

Memberships can be put on hold up to 1 month for any reason, and up to 3 months for medical reasons. Any reason further is based on director's consent.

Should your annual monthly membership payment not be received per the BPRD agreement timeframe, you will be allotted 30 days to bring account current. If it is not brought current within the 30 days your membership may be subject to cancelation. You may not qualify for monthly payment options again should you choose to re-activate your membership.

Expected Behavior

Bennett Park and Recreation District is an inclusive, family-friendly organization. We expect all our members and guests to model good sportsmanship, kindness, honesty, respect, and responsibility—in their conduct and language. BPRD has the right to terminate a membership at our discretion if actions or behaviors are not deemed in the best interests of the organization; no refund or credit will be issued.

- •No running or horseplay in the hallways.
- •Profanity or vulgar language is not allowed.
- •Food or drink will only be allowed in the front lobby and hallway or approved areas. All other areas are for exercise and recreational activity. Drinks in plastic bottles with re-sealable tops and water bottles are an exception.
- •No fighting. There is a zero tolerance for violence, harassment, or intimidation of any sort.
- •All clothing attire must be worn appropriately. Shirts and shoes must be worn at all times. Non-marking athletic shoes are allowed. Shorts and pants must not be sagging.
- •Alcoholic beverages, smoking, illegal drugs, firearms and tobacco products are not allowed in the recreation center.
- •Bicycles, roller blades, and skateboards are not permitted in the building.
- •No soliciting for personal gain: or approaching guests for the purpose of obtaining signatures for petitions within the building.
- •No harassment of any kind, to any other guests or staff.
- •Theft should be reported immediately to staff at the front desk who will file an incident report with local law officials.
- •Vandalism: The recreation Center interprets vandalism as the willful or malicious destruction or defacement of property. The Recreation Center has zero tolerance to any damage caused by vandalism. The Director will determine disciplinary action taken due to vandalizing the center. The abuser will be 100% financially responsible for fixing or replacing the item that was vandalized.

Violations of any of the above policies will result in either a verbal warning or outright ejection from the Bennett Recreation Center. Any negative behavior may result in loss of facility privileges and denied access to the facility. **Failure to comply with the policy after being notified by a staff member may result in the summoning of the local police and prosecution in accordance with the law.**

Services for People with Disabilities

Bennett Park and Recreation District serves people of all abilities. We provide reasonable accommodations to enable all people to participate in our programs and classes.

Before starting any exercise program, please check with your primary care physician. Participating in physical activities here at BPRD are voluntary and patrons assume every risk and responsibility involved with such participation.

Your Membership Card

Your membership card is your access to Bennett Park and Recreation District (BPRD). Membership cards must be presented during each visit. When purchasing a Membership, you must present proof of residency.

Lost or stolen membership cards must be replaced. The fee is \$5.00. Members are granted one courtesy entrance without a pass. No other exceptions will be made.

Definitions of Membership types:

Families: A family membership consists of immediate family members defined as follows: Mom/Dad/Guardian and their children (or custody of grandchildren) 18 and below whom are their tax dependents. If the family has children that are 18+ and in college or the child is 18+ and ADA, then they may be added to the family membership. Any other combinations of family members are not permitted to be on the family membership.

A family is considered 2 adults and their 3 tax dependents. Additional tax dependent family members may be added at a onetime rate of \$100 per dependent.

An additional senior living in household, or on property may be added to a family membership at $\frac{1}{2}$ the amount of the senior membership rate.

Couples: A couple consists of two people on the same membership. Acceptable combinations are: Two adults, an adult and guardian child, or any other combination that has two consenting adults that choose to be on the same membership.

Senior: A senior is a person who is 60 years or older.

Adult: An adult is a person who is 19 years - 59 years of age.

Teen: A teen is person 13 years -18 years of age.

Teen members may not sign membership form or credit card form. The membership form and credit card form must be signed by guardian or Parent of Teen.

Youth: A youth is any child 6 months - 12 years of age

Youth member may not sign membership form or credit card form. The membership form and credit card form must be signed by guardian or Parent of Youth.

Discounts:

-Discounts apply to person owning the membership only.

-Child must be included in membership to receive any discount on youth programs/leagues.

-League Discounts 10% for classic members, 15% for deluxe members. NO discount for basic members.

-10% renewal discount for classic and deluxe memberships (no discount for basic). 25% renewal discount on classic & deluxe memberships for first responders, military personnel and educators (no discount for basic).

Membership Benefits:

Basic Memberships Basic use of the facility; gymnasium, weight room and cardio equipment. This membership does not include aquatic facility usage (lap swimming, open swim, continuous pool or steam rooms), land or aquatic fitness classes.

<u>Classic Memberships</u> Includes basic facility usage, land classes, continuous pool, steam rooms, daily utilization, open swim, and lap swim. <u>Deluxe memberships</u> Includes basic facility usage, land and aquatic classes, continuous pool, steam rooms, daily utilization, open swim, and lap swim.

Medical Membership Holds

Memberships may be put on hold for up to 90 days, at the approval of the director, for medical purposes. Forms can be filled out at the front desk and turned into the Director for approval. Approved medical holds will have that time added onto the end of their membership timeline. No refunds are given.

Facility Closures

BPRD will be closed for inclement weather. When the highway is closed, the facility will be closed. When school is canceled, but the highway is open, BPRD will have a delayed opening to allow time for the roads and parking lots to be cleared. In the event that BPRD becomes an emergency shelter, the facility will be closed and not available for it's members to use for recreational purposes. Occasional hours of operation have to be altered, updates will be given on the website and FB page. BPRD will be closed for major holidays; New Years Eve and Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and the Friday following, Christmas Eve and Christmas Day. If any of these holidays fall on a Saturday or Sunday, BPRD may be closed an additional day in observance of these holidays.

Program/Class Cancelations

BPRD reserves the right to cancel or combine classes because of insufficient enrollment or conditions beyond our control. Class schedule is subject to change and availability. Refunds or credits will not be given for canceled or rescheduled classes.

Weight Room/Cardio Area

Individual's must be 15 years of age to use the equipment in the weight room. 11 years of age may use equipment if a parent/guardian is with them, within arms reach, at all times.

Weight Room/Cardio Area Rules

- 1. Wear shirts and close toed shoes at all times. (no flip flops, sandals, crocs, or slippers)
- 2. Share equipment in between sets.
- 3. Monopolizing equipment slows the workouts of others. Please, help maximize use and put your equipment away when finished.
- 4. Keep equipment in the weight room.
- 5. Help us prevent theft and maximize equipment use by keeping it where it can be seen and used.
- 6. Re-rack weights immediately when finished with them.
- 7. Help us keep the weight room safe and accessible to as many users as possible.
- 8. Store belongings in area provided.
- 9. Please wipe off equipment after use.
- 10. Children 10 and under are not allowed in the weight room under any circumstances.
- 11. Don't drop or bang weights.
- 12. Avoid distracting others. Please respect others need to concentrate.
- 13. Be mindful of safety.
- 14.Do not step on the weight benches.

Pool Rules/Regulations

Although swimming is a fun way to get exercise and enjoy the water, we also want you to be safe in and around the pool. A complete listing of pool rules is posted in the pool area, but here are a few that you need to be aware of before coming to the pool. IF YOU CANNOT SWIM, YOU ARE

NOT ALLOWED IN THE POOL WHEN THERE IS NO LIFEGUARD ON DUTY.

-All patrons must take a shower, getting wet from head to toe before entering the water.

- -Proper swimming attire must be worn at all times. (No street clothes, no basketball shorts)
- -Only children 5 years of age or younger are permitted in the toddler pool.
- -There is no lifeguard on duty during lap swim. Swim at your own risk. Lap swim waiver is required.
- -The continuous pool is available by reservation only to classic & deluxe members.

-THERE ARE NO CHILDREN (under the age of 18) PERMITTED TO BE IN THE POOL AT ANY TIME UNLESS THERE IS SCHEDULED OPEN SWIM. OPEN SWIM MEANS THAT THERE IS A LIFEGUARD ON DUTY, DURING SCHEDULED TIME FRAMES ONLY. PLEASE CONTACT THE FRONT DESK FOR SCHEDULED OPEN SWIM TIMES.

Please see rules for open swim below:

-Children 5 years and younger must have a chaperone (15 years or older) in the water within arms reach at all times.

-Children 6-10 years old must be accompanied by a chaperone 15 years or older.

-Children who are not potty-trained must wear swim diapers.

-Children who cannot swim and need a floatation device while in the water must have an adult within arms reach of them in the water at all times.

Continuous Pool

- -Included in classic and deluxe memberships by reservation only. Rate of rental for basic members is \$10 per 30 minutes.
- -Reservations are made at the front desk (in-person or over the phone) for 30 minutes at a time.
- -Up to 2 people are allowed to use this pool at the same time.

-Remote must be checked out at the front desk upon arrival and returned upon leaving.

Steam Rooms

-Included in classic and deluxe memberships by reservation only.

- -Reservations are made at the front desk (in-person or over the phone) for 30 minutes at a time.
- -Up to 2 people are allowed to use the steam room at the same time.
- -Users must clean the steam room, with the cleaner spray bottle and rag provided, located by the steam rooms.

I understand that I am encouraged to use the "buddy system" (meaning I should not be in the pool with less than 1 other lap swimmer).

I understand that no lap swimmer will be allowed in the pool unless BPRD has an executed waiver on file.

I agree to assume all fiscal responsibility for medical rescue or other expenses that I may incur as a result in participating in unsupervised lap swim.

I acknowledge that failure on my part, whether direct or indirect, to comply with these requirements and acknowledgments, shall result in the revocation of my right to use the pool for lap swimming purposes.

RISK WAIVER & RELEASE OF LIABILITY

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/ activities, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these programs/activities against the Bennett Parks and Recreation District including its officials, agents, volunteers and employees. I do hereby fully release and forever discharge the Bennett Parks and Recreation District from any and all claims for injuries, damages, or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with these programs or activities. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims.

By signing this form you are agreeing that you will not enter the facility if you are exhibiting a fever or any flu or COVID like symptoms. You also agree that you will wipe down and clean the equipment before and after use. Violation of these terms will result in you being asked to leave the facility, repetitive violations will result in your membership being canceled. Refunds/credits will not be given.
