ALL TEAM MEMBERS MUST COMPLETE THE FOLLOWING STEPS TO BE CONSIDERED A REGISTERED TEAM. ALL STEPS MUST BE COMPLETED ON OR BEFORE THE REGISTRATION DEADLINE. FAILURE TO COMPLETE THE STEPS WILL RESULT IN AN INVALID TEAM AND YOU WILL NOT BE ADDED TO THE SCHEDULE.

- Fill out ALL personal information on the registration form
- Sign registration form
- Pay for league in full
- Submit completed registration to BPRD on or before registration deadline

CAPTAINS: Before registering you must adhere to the following registration rules:

1. All players must READ AND SIGN the BPRD Code of Conduct and Assumption Waiver
2. Players are ineligible unless their names are on the roster, NO SUBS.
3. You must be 16 years of age with parent/guardian signature to participate in this league

PENALTY FOR FAILURE TO ADHERE TO ABOVE RULES: Forfeiture and possible suspension or disqualification without refund.

ASSUMPTION OF RISK WAIVER

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these programs/activities against the Bennett Parks and Recreation District including its officials, agents, volunteers and employees. I do hereby fully release and forever discharge the Bennett Parks and Recreation District from any and all claims for injuries, damages, or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with these programs or activities. I have read and fully understand the above important information, warning of risk, assumption of risk and waiver and release of all claims.

By signing this form you are agreeing that you will not enter the facility if you are exhibiting a fever or any flu or COVID like symptoms. You also agree that you will wipe down and clean the equipment before and after use. Violation of these terms will result in you being asked to leave the facility, repetitive violations will result in your membership being canceled. Refunds/credits will not be given.

TEAM/PLAYER RULES & CODE OF CONDUCT

1. **THERE WILL NOT BE CERTIFIED OFFICIALS/REFEREES IN THIS LEAGUE.** Some of our officials, referees, score keepers, line judges and/or other volunteers may be under 18 years of age; any harassment or verbal abuse of a minor will be documented and provided to that minor's parent/legal guardian and local law enforcement.
2. **Spectators are required to follow the same rules as players.** Coaches and team participants are responsible for the conduct of spectators associated with their team **BEFORE, DURING AND AFTER** the game. Failure to adhere to the BPRD CODE OF CONDUCT may result in ejection, game forfeiture and/or a call to local law enforcement, including a written report of all members involved in the incident.
3. **Bennett Park and Recreation District reserves the right to prohibit individuals from attending any game.**
4. **All ejections carry a minimum of 1 game suspension to be served at the team's next game.** Suspensions may be longer depending on the Sports Director's discretion. Officials/Referees, the Sports Director and BPRD staff are empowered to EJECT AND SUSPEND coaches, players or spectators for any misconduct or violation of the **BENNETT PARK AND RECREATION DISTRICT FACILITY RULES** or the **BPRD CODE OF CONDUCT**
5. All coaches, players and spectators will abide by the official's decisions, including a decision concerning the team's conduct.

Anyone in the Bennett Park and Recreation District facility may be dismissed from the facility, followed by a call to local law enforcement for any of the following infractions:

- Approaching an official/referee at any time
- Involving themselves in a physical altercation with another player, coach or spectator
- Uses vulgarity, profanity of any type and is unsportsmanlike in their conduct
- Taunting or mocking BPRD league officials, employees, players or spectators
- Lay a hand upon, push, shove or verbally threaten an official, coach, spectator or BPRD employee
- ***No refund will be granted to individuals who are dismissed from the facility for any reason***
