SWIM WAIVER

Swimming under this waiver releases Bennett Park and Recreation District, it's employees, members, patrons, volunteers and board members from any responsibility in the event of any injury, accident, illness, death or loss incurred while using the aquatic facility.

Swimming under this waiver is also subject to agreeing to all conditions as described in the Pool Rules & Regulations posters that are in the aquatic facility. By signing this waiver, you are agreeing that you have read, fully understand, and are responsible for complying with the Pool Rules & Regulations as well as the posted facility rules.

Please initial next to each statement acknowledging you have read them and will abide by the rules of participating in this program:

I understand that there may not be a lifeguard will be on duty at the time I/my minor children will be swimming.

I understand that I/my minor children must sign in and out for record keeping purposes.

I understand that I/my minor children must wear appropriate and approved swim wear inside of the pool at all times.

I understand that I/my minor children must take a shower, getting wet completely from head to toe, before entering the pool (as per the local health department's regulation).

I understand that I/my minor children are not allowed to be in the water without direct supervision by the adult giving the lessons. Students are expected to sit on the bleachers/benches in the aquatic area and wait for their teacher to be ready for them. Any student who breaks this rule and enters the water without permission will forfeit their participation in this program and refunds/credits will not be given.

I agree to assume all fiscal responsibility for medical rescue or other expenses that I/my minor children may incur as a result in participating in this aquatic program.

I acknowledge that failure on my/my minor children's part, whether direct or indirect, to comply with these requirements and acknowledgments, shall result in the revocation of my right to participate in this aquatic program.

I understand that I will be held liable for any lost, damaged, or broken property or equipment that I/my minor children cause while participating in this program.

I understand that swim lessons are not refundable or transferable. No credits will be given for cancelled, missed or no-show appointments. A 48 hour notice is required to re-schedule a private or semi-private lesson, group lessons cannot be rescheduled. Lack of a 48 hour notice will result in a no-show. Being more than 10 minutes late to your scheduled lesson will result in a no-show. No-show lessons will not be rescheduled or made up.

RISK WAIVER & RELEASE OF LIABILITY

I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation.
