

Payment Option Agreement

- -The first payment will be due upon registration or the first day of swim practice (September 19th, as scheduled) and will not be accepted any later. There is no option to pay after your child/children have started on the team.
- -The second and third payment will be due **no later than** October 5th and November 9th.
- -Failure to pay the agreed amount of _____ by the above due dates will result in your child/children being removed from the program.
- -There will be no discount, credit, or refund given if your child/children does not complete the season OR for any cancellations, closures or delays in the program. By signing your child up for this season of swim team you agree to their full participation and accept that there will be no reimbursement if you chose to end the season early or miss it in part.

Youth Code of Conduct

Preamble

The essential elements of character building and ethics in sports participation are embodied in the concept of sportsmanship and six core principles: trustworthiness, respect, responsibility, fairness, caring and good citizenship. The highest potential of sports is achieved when competition reflects these "six pillars of character".

I therefore agree:

- 1. I will remember that children participate in sports to have fun and that the game is for the youth, not the adults.
- 2. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
- 3. I will learn the rules of the game and the policies of the league.
- 4. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, by demonstrating positive support for all players, coaches, officials and spectators at every game, practice and other sporting event.
- 5. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player or parent such as booing and taunting, refusing to shake hands, or using profane language or gestures.
- 6. I will not encourage any behaviors or practices that would endanger the health and wellbeing of the athletes.
- 7. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
- 8. I will see to that my child treat other players, coaches, officials and spectators with respect; regardless of race, creed, color, sex or ability.
- 9. I will praise my child for competing fairly, executing the required skills and trying their best to improve.
- 10. I will emphasize skill development and individual effort over winning.
- 11. I will cultivate age appropriate expectations for my child and his/her teammates.
- 12. I will promote the emotional and physical well-being of the athletes ahead of any personal desire I may have for my child to win.
- 13. I will respect the officials and their authority during games and will never question, discuss, or confront coaches at the game field; I will take time to speak with coaches at an agreed upon time and place (which will not be on game day).
- 14. I will not tolerate the use of illegal drugs, tobacco, alcohol and vulgar language, and I will refrain from their use in my child's environment.
- 15. I will refrain from coaching my child or other players during games and practices, unless I am one of the official coaches of the team.

I also agree that if I fail to abide by the aforementioned rules and guidelines, I will be subject to disciplinary action that could include, but is not limited to the following:

- · Verbal warning by official, head coach and/or head of league organization
- · Benched for 1 practice or more
- · Removal from program with no refund or credit
- · Referral to legal authorities (as required for abuse)

I UNDERSTAND THAT MY STUDENT ATHLETE WILL BE REQUIRED TO SIGN A CODE OF CONDUCT ON THEIR FIRST DAY OF PRACTICE (STATING BULLYING IS NOT ALLOWABLE, RESPECT, PRIVACY AND HONESTY ARE REQUIRED AT ALL TIMES) AND FAILURE TO SIGN WILL RESULT IN THEIR REGISTRATION BEING CANCELED.

IF THESE RULES AND REGULATIONS ARE VIOLATED, OR SAID FORM IS NOT SIGNED BY MY STUDENT ATHLETE, MY STUDENT CAN BE REMOVED FROM THE TEAM WITHOUT REFUND.

PLEASE NOTE- AS FIRST REPORTERS WE ARE REQUIRED BY LAW TO REPORT ANY FORM OF ABUSE.
